Bids Disqualified:

M/s Honda United is <u>technically disqualified</u> due to the fact that eligibility criteria as mentioned in the tender document required "Details of financial turn-over of at-least past three years supported by income tax return document or financial audit report". The bidder provided only a bank certificate from Meezan Bank stating credit and debit transactions. Based on missing document required in the eligibility criteria for evaluation, the bidder is considered non-responsive for further processing.
