**Summary:**

In result of publication of tender, four bids were received from the following bidders

(1) M/s Excel Tex Ind Pvt Ltd, (2) M/s S. Hussain & Sons (3) M/s Eastern Trading and (4) M/s Chiragh Din & Sons.

The technical evaluation committee thoroughly reviewed the technical proposal of each bidder in light of the technical evaluation criteria defined in the tender document.


**Result of Technical Evaluation** (*duly signed technical evaluation report is attached*):

**Bid(s) Qualified:**

- M/s Excel Tex Ind Pvt Ltd, M/s Chiragh Din & Sons, and M/s S. Hussain & Sons are **technically qualified** after meeting all aspects of eligibility criteria as defined in the tender document.

**Bid(s) Disqualified:**

- M/s Eastern Trading is **technically disqualified** due to the fact that the provided bid security of 2% of contract value is lower than the actual requirement. Bid security required amount is Rs. 529,112, whereas submitted pay order # 16573202 drawn on Habib Metropolitan Bank is Rs. 526,496 that is Rs. 2,616 short of required amount and hence the bidder is considered unresponsive for further processing.

**VISUAL INSPECTION OF SAMPLES**

- The samples of uniforms excluding shoes submitted by bidders (1) M/s Excel Tex & (2) M/s Eastern Trading are in different colors and not as per the requirement of the tender document which are not acceptable and hence rejected for further processing by the technical evaluation committee.
- The samples submitted by the bidders (1) M/s Chiragh Din & Sons and (2) M/s S. Hussain & Sons are as per requirement of tender document based on visual inspection.

The SR # (Item 5, Safety Shoes) quoted by M/s Excel Tex Ind Pvt Ltd was technically rejected by the technical evaluation committee after thorough review and compared with the existing Safety Shoes which pictures was also made available in the Tender document however, due to inferior quality the sample of M/s Excel Tex Ind Pvt Ltd was rejected. The sample submitted by M/s S. Hussain & Sons and M/s Chiragh Din & Sons were technically accepted. Bases on lowest price of technically accepted samples of Safety Shoes M/s Chiragh Din & Sons is recommended to award the contract.

**RECOMMENDATION**


The only one sample of Uniforms items for SR# (items 1, 2 & 3) is technically approved and also found at quoted lowest prices. The procurement committee recommends the award of the contract to **M/s Chiragh Din & Sons** for all Uniform items mentioned above in SR# 1, 2, 3, 4, 5 considered as most advantageous bidder.

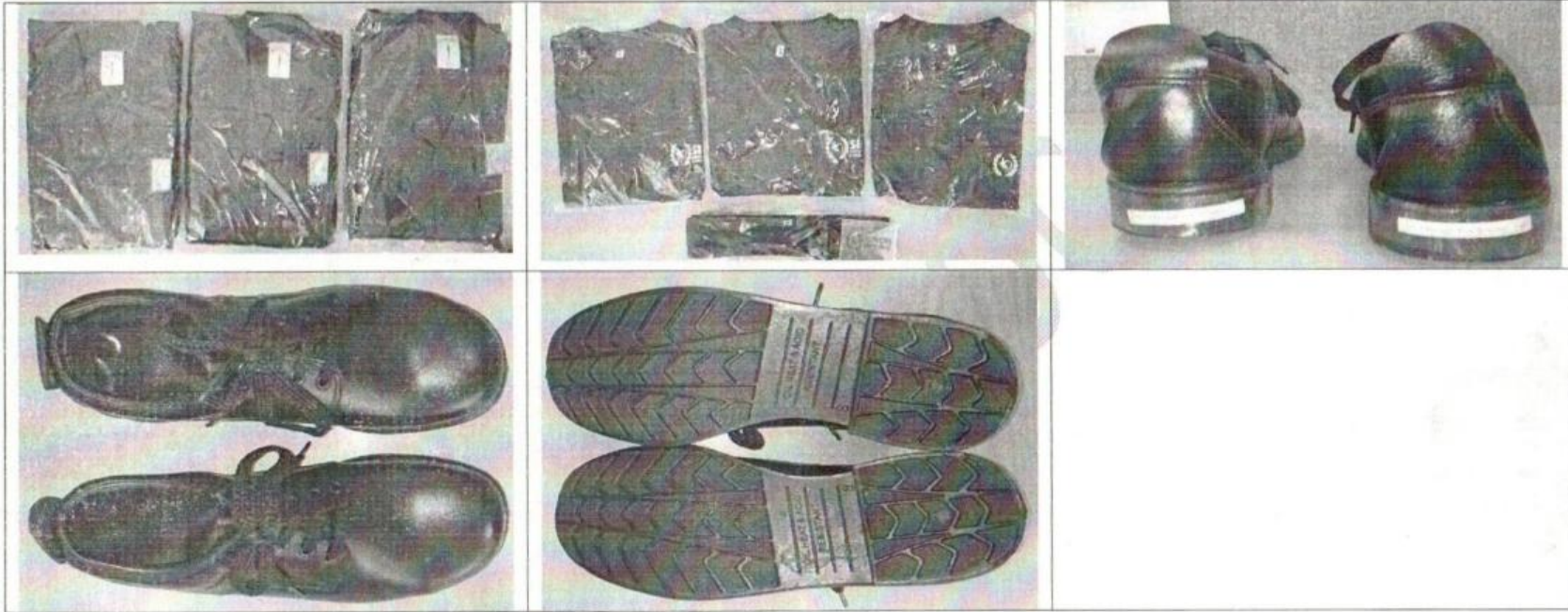

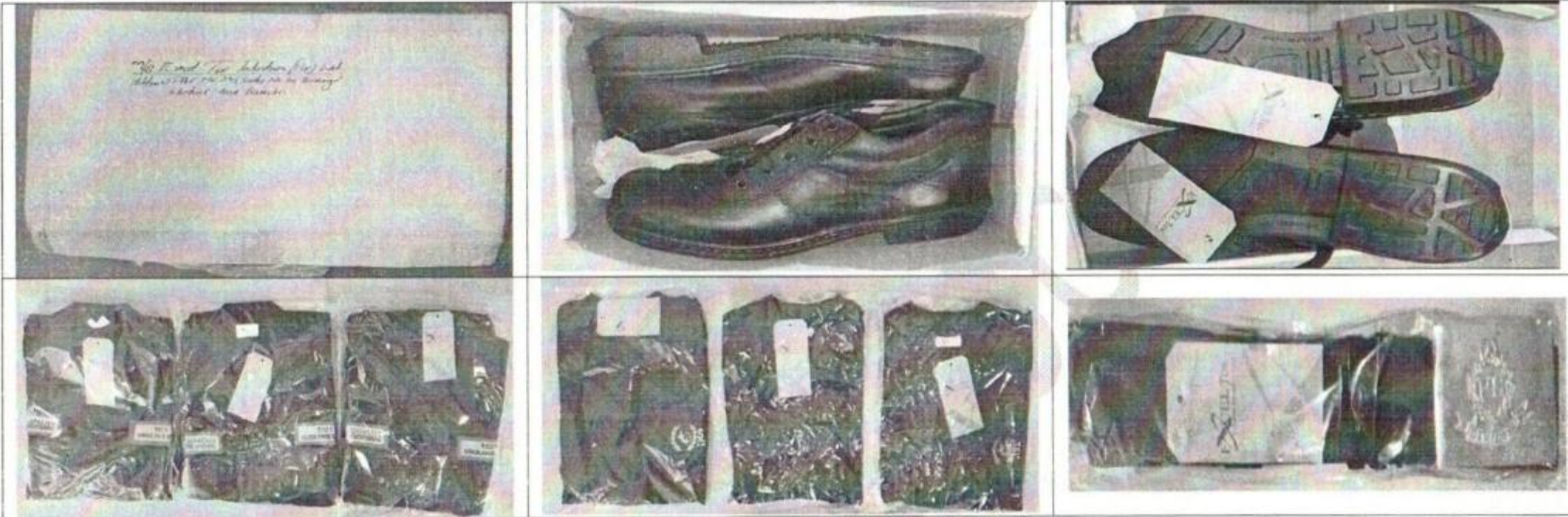
