In the result of publication of tender, three bids have been received from the following bidders:

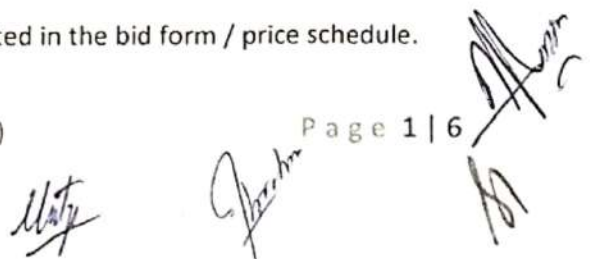
- Bidder-1: M/s. Megaplus, Pakistan

- Bidder-3: M/s. Computer Marketing Company

The documents of all bidders verified by the technical evaluation committee, all bidders are found technically qualified. However, **M/s. Supernet (Pvt) Ltd is recommended to award** on the basis of overall highest score in technical & financial evaluation as per the following evaluation criteria mentioned in the tender document:

Evaluation Criteria of the Tender Document
BID EVALUATION CRITERIA - 100 Marks

THE BIDS SHALL BE EVALUATED ON MOST ADVANTAGEOUS BID BASIS. The bidder which attains the highest combined weighted technical and financial score according to the following criteria shall be selected.

1. The Bids shall be evaluated on location basis reflected in the bid form / price schedule.



2. The following merit point system for weighing evaluation factors / criteria will be applied for technical proposals.

Bidders achieving minimum 70% overall points / marks will be considered only for further process. Documentary evidence must be attached in support of your claim.

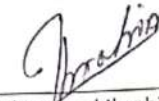



Recommendations:

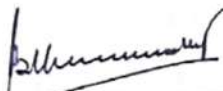

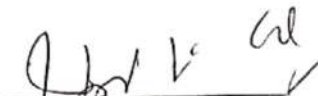
